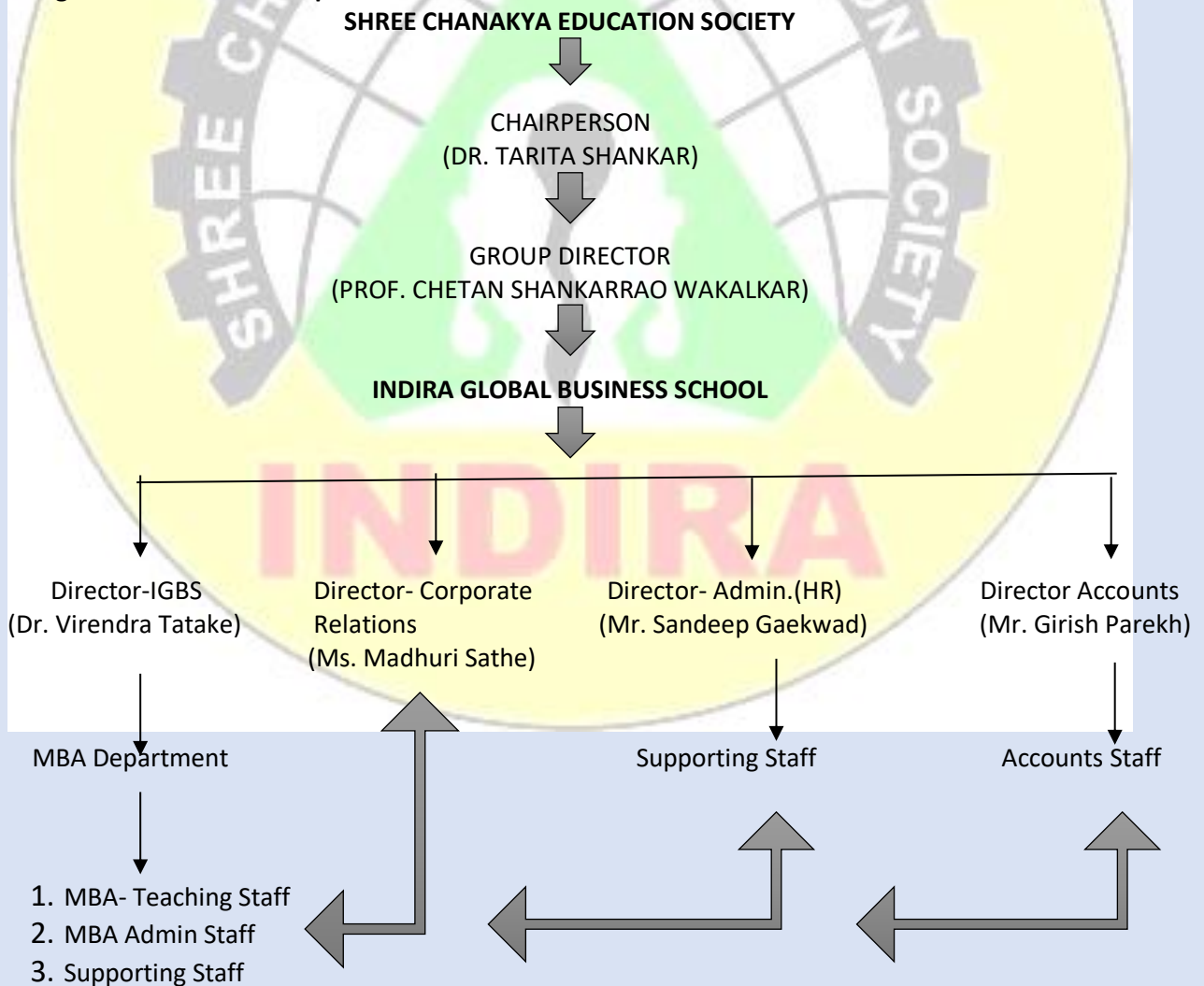

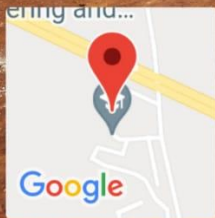
SPLASH-CULTURAL EVENT

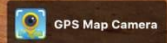


SPRINT-THE ANNUAL SPORTS EVENT
